Volunteer Income Tax Assistance Yearly Report 2013

Taxpayers pay, on average, \$246 to have their income taxes prepared and filed each year, according to 2013 data from the National Society of Accountants. Most taxpayers do not have the funds to pay for these services, causing them to miss out on crucial tax credits that can substantially increase their annual household income. Goodwill prepares and files income tax returns for *no charge*, allowing taxpayers to keep every dollar of their hard-earned money.

Goodwill uses the IRS phrase "Earn It, Keep It, Save It" as a reminder for taxpayers and volunteers throughout the year. The income tax refund is the largest paycheck for many taxpayers, and Goodwill's volunteers make sure that clients receive all the credits they qualify for each income tax season, including the American Opportunity Credit for college students and the Earned Income Tax Credit for working taxpayers.

Tax Season Highlights

New initiative: financial festival!

Goodwill developed a "financial festival" this year at its Rockford tax site. This initiative brought together local financial experts to serve as resources at a one-stop financial wellness event. Goodwill's partners this year included MembersAlliance Credit Union, Family Credit Management, Prairie State Legal Services, Super Shredders, Northern Illinois Food Bank, and Rock Valley College. Over 70 families participated in this event. Booths included the following topics: credit reports, checking and savings accounts, job search assistance, legal advice, low cost internet and phone service, food benefit screening and sign-up, and college education programs and FAFSA assistance.

New focus: pre-season education!

Goodwill hosted an educational seminar before the tax season began, in an effort to education local service providers and non-profit agencies on the importance of tax time credits. Through training provided by the Center on Budget and Policy Priorities, Goodwill was able to provide educational outreach to more than twenty local agencies. Providing pre-season education means more awareness, more understanding, and more families who are educated about the importance of filing their tax returns in order to claim valuable tax time credits, including the Earned Income Tax Credit and Child Tax Credit.

New focus: employee engagement!

This year Goodwill has focused more on its employees and their financial wellness, in addition to the communities we serve. Taxes are an important piece of our financial puzzles, and through education and free tax preparation services, Goodwill is able to help put more money into employees' pockets each year. 69 employees used Goodwill's free tax preparation services this year at 13 different locations throughout northern Illinois, reflecting the participation of more than 20% of all employees.
